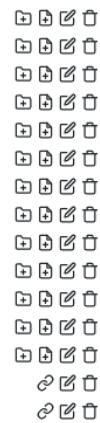
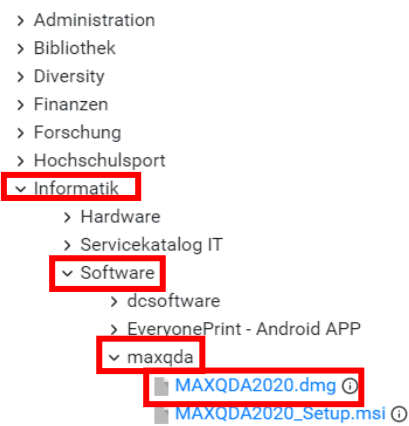


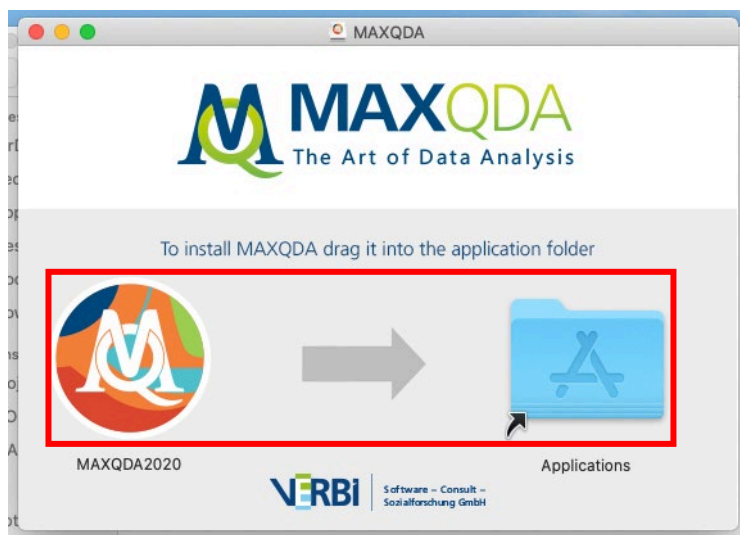

### § 1 Subject Matter

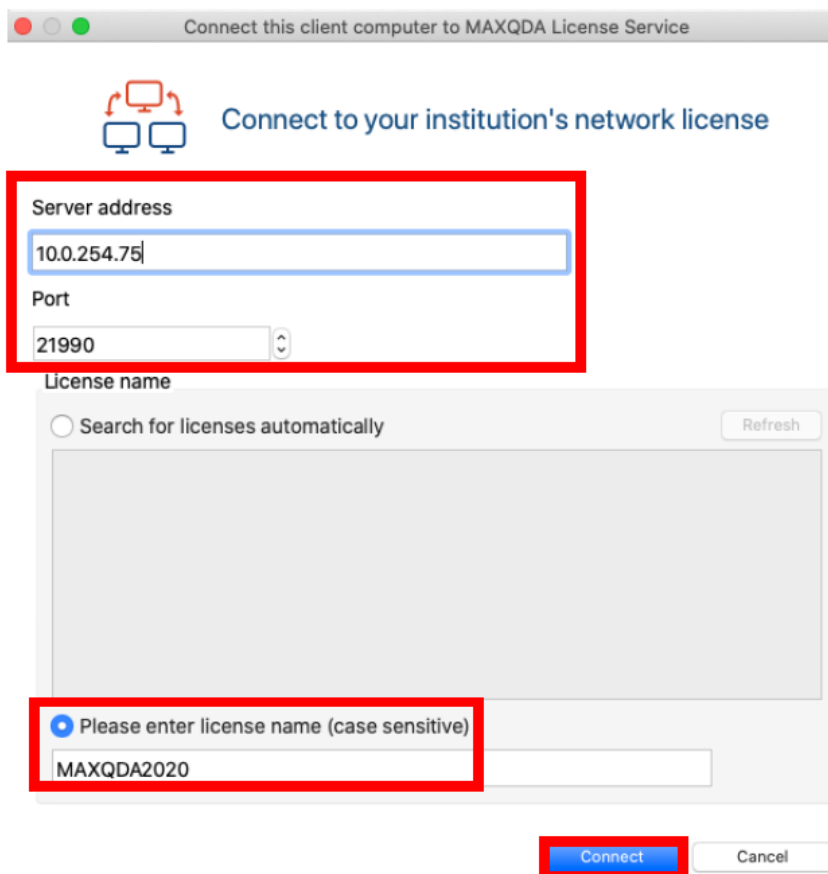
